1	Income Tax Officer	22-05-2025	The CPC has processed the Income Tax Return for AY 2024-25 on May 22, 2025 computing total income at Rs 4,32,28,580 as against the Nil income declared by the company. Further, we have also noted that the CPC had allowed short credit of TDS of Rs 3,94,549. In the intimation u/s 143(1) of the Act, the issue pertains to allowability of deduction u/s 80M of the Act wherein the CPC had computed deduction to the extent of Rs 19,00,45,427 instead of Rs 23,32,74,007 as claimed in ITR. The short deduction u/s 80M of the Act of Rs 4,32,28,580 is because the CPC has first set off the business loss against the other source income and not against the STCG as per the ITR. As a result of the above, the Income Tax Department has determined refund lesser to the extent of Rs. 1,12,73,566. Considering this being a recurring issue and company has preferred appeal for the earlier years. The Company has filed an appeal before the CIT(A) on the ground that the CPC has erred in computing set-off of business losses and consequently computing the amount of 80M deduction	The hearings from CIT (A) are pending
